NEOLIBERALISM DO ENVIRONMENTAL FIX FOR THE CRISIS OF CAPITALISM—THEY DO THIS THROUGH ATTACKING REGULATIONS, THEY JUST ALLOW A SOURCE OF PRODUCTION WHERE THERE ARE FEWER ENVIRONMENTAL REGULATIONS AND THIS WAY THEY DIMINISH EASILY THE ENVIRONMENT. FREE TRADE DEAL ALLOWS FOREIGN MULTI—NATIONAL CORPORATION SOUGHT GOVERNMENTS IN A SECRET TRIBUNAL OUTSIDE THE JUDICIAL SYSTEM—WHICH IS NEVER BE GOOD.
